Agreement and Release**

**WITNESSETH**

WHEREAS, Moulin Rouge operates a dance studio wherein dance is taught for tuition, and at times, students participate in recitals, parades and trips related to these lessons; and

WHEREAS, Parents/Guardians of \_\_\_\_\_, who is \_\_\_\_\_ years of age and who is a student or potential student of Moulin Rouge; and

WHEREAS, the parties understand that there are inherent risks of injury in learning the physical things Moulin Rouge teaches to its students; and

WHEREAS, the parties hereto wish to set forth their understandings and agreements in regards thereto.

NOW THEREFORE, in consideration of the tuition paid from time to time and the permitting of the above-named student to participate in such programs, the parties agree as follows:

1. Moulin Rouge will undertake to teach student those things for which student is enrolled and agrees to take all reasonable measures and precautions to see that student is taught and supervised safely while in its care. Moulin Rouge will exercise its best efforts to see that the instruction is performed in a reasonable and safe manner and that student is not exposed to unreasonable or unnecessary risks.
2. Parents agree that student has their approval and consent to participate in any and all activities of the program in which the student is enrolled and understand that in doing so, they are assuming the inherent risk of any injury to student as a result of the normal instruction and activities.
3. Parents further agree and do hereby waive and release Moulin Rouge, its employees and agents, from any and all causes of actions or claims for relief resulting directly or indirectly from injury which may occur while the student is participating in their program or any activity incidental thereto, willful or wanton acts or omissions excepted.
4. Parents further agree to punctually pay tuition and to deliver and pick up students at all lessons and activities or advise Moulin Rouge of circumstances which may cause parents to be late. Parents understand that it is critical for the students’ safety that they be picked up punctually when the lesson or activity is completed.
5. Moulin Rouge agrees to advise parents of special instructions in scheduling by means of handouts given to the students of which parents should inquire of the students.
6. The parties agree and understand that misconduct of the student as determined in the sole discretion of Moulin Rouge, failure to pay tuition or failure by the parents to have the student punctually picked up after lessons are complete may result in a dismissal of the student by Moulin Rouge.
